### Collision Insurance Deductible Options

- \$0 Collision Deductible AutoShare Coverage**
  - \$50 annual fee – complete the form on the following page.

- \$500 Collision Deductible**

**Important Note:**

A \$500 insurance deductible applies to all non-collision perils (e.g. Liability, Accident Benefits) regardless of collision coverage chosen above. Members will need to pay the deductible if the incident is deemed at fault by our insurer.

### Payment Option - Telephone/Internet Banking or Cheque

I wish to pay my monthly AutoShare invoices and any miscellaneous charges (e.g. damage) by one of the following options: I understand and agree that I will always receive an invoice each month by mail or email and that AutoShare may contact me at anytime to arrange immediate payments if my account (including the current month) exceeds \$250. AutoShare may amend the Payment Due Date or Debit Date at any time by providing one weeks notice.

- Pay by Telephone/Internet Banking or cheque by the invoice due date. In the event the account is past due by the Payment Due Date (currently end of the month), the below credit card will be debited. (Allow at least 2 business days for payments to be processed & received by AutoShare)

## **\$0 Deductible Collision Coverage (\$50 Annual Fee)**

I, \_\_\_\_\_ am member # \_\_\_\_\_ in AutoShare – Car Sharing Network Inc. (AutoShare), and wish to subscribe to the “\$0 Deductible” Coverage by paying an annual \$50 fee.

I understand that:

- I will not have to pay any (\$0) deductible for damage to an AutoShare vehicle damage where I am found responsible (at-fault).
- This coverage does not reduce the membership fee I would have paid to become a member. The membership fee is still required as a security and to cover a deductible that may arise from a liability or personal injury claim.
- I need to report any damage that occurs during my reservation within 48 hours by calling the AutoShare office at 416.340.7888
- coverage will be limited to \$500 annually; after which I will be responsible for the regular insurance deductible.
- I will retain Third Party Liability, Personal Injury, Damage to Property and any other insurance provided by AutoShare’s insurer where a deductible may still apply.
- I need to remain a member in good standing by paying my monthly invoice on time.
- I am not purchasing, nor is AutoShare selling, insurance through this agreement

This coverage does not include any loss arising directly or indirectly from:

- damage caused by putting regular fuel into a Diesel fuel vehicle (e.g. Smart).
- non repairable tire damage (e.g. tire driven on while flat)
- personal injury, or damage to property, except the reserved vehicle itself or it’s equipment.
- third party liability
- dishonest, fraudulent or criminal acts
- violations of the Terms and Conditions of Membership
- intentional damage to the reserved vehicle by the member

I also understand that my reduced (\$0) deductible will be active only after AutoShare has:

- Received this signed form by fax, mail or other means during regular business hours;
- Confirmed that my account is in good standing, and added the \$50 charge to my account, for payment on my next invoice;
- Acknowledged the above by indicating my “\$0 deductible” status in “My Info” section in the Online Reservation System (which I can check myself by logging in).

I hereby authorize AutoShare to charge my account \$50 annually, starting on the date below or the date AutoShare acknowledges receiving this form (whichever is later).
