_____, herein called "The Corporation", is applying for Membership in AutoShare – Car Sharing Network Inc.

The Corporation recognizes and agrees that:

- if AutoShare accepts this Application, the Application will become a binding contract, and
- AutoShare's acceptance of this Application is subject to a successful check of Driver's License and Driver's Abstract for each Employee-Driver and payment agreement.

The Corporation confirms that it agrees to comply with the Terms and Conditions of Membership, available at www.AutoShare.com/terms. The Corporation agrees to cause its Employee-Drivers to comply with Terms and Conditions of Membership, as applicable. The Terms and Conditions of Membership describes the rights and responsibilities of Members, including Corporate Members and their Employee-Drivers, and AutoShare. The Corporation recognizes that AutoShare may amend the Terms and Conditions of Membership and Price List at any time.

If the Corporation's Application is accepted, the Corporation understands that AutoShare will endeavor to ensure vehicles are clean, reliable and well maintained and will periodically inspect the vehicles. However, we recognize that:

- The Corporation and their Employee-Drivers share responsibility for the maintenance and safety of vehicles and prompt reporting of any problems by phone;
- AutoShare's periodic inspection of vehicles is supplementary to the inspection of vehicles by Employee-Drivers;
- AutoShare does not make any representations or warranties as to the fitness or condition of any vehicle.

The Corporation will be responsible for paying any fees owing to AutoShare arising out of its Employee-Drivers' use of AutoShare Vehicles. The Corporation agrees that this money will be a debt due and payable to AutoShare. The Corporation understands that AutoShare will ensure that vehicles are insured under a standard insurance policy. The Corporation understands that it is responsible for the Insurance Deductible (as defined by the Terms and Conditions) and any costs

not covered by insurance on claims where its Employee-Driver is deemed at-fault. The Corporation further understands that they will be charged for repairs less than the Insurance Deductible where any Employee-Drivers are at fault.

The Corporation recognizes that AutoShare will not give The Corporation any warranty or guarantee except as follows: AutoShare will use reasonable care in the performance of its services. AutoShare will have a program of regular preventative maintenance and will deal in a reasonable way with defects that are reported to it. However, AutoShare will not be liable to The Corporation or Employee-Drivers or anyone else for any damages or losses however caused arising out of or in connection with:

- a vehicle not being available when it was supposed to be: and/or
- any malfunction of or deficiency in a vehicle, whether or not by accident, physical injury or property damage results and/or
- any defect in a vehicle, or any breach of warranty or other obligation by any manufacturer or supplier or repairer of a vehicle.

The above expresses the full obligation of AutoShare to The Corporation and is instead of any other warranty, whether expressed or implied. In no event will AutoShare be liable for any damage or injury to persons or property, or loss of profits, or any indirect or consequential damages, however caused.

This agreement cannot be terminated by The Corporation until all monies owed AutoShare have been paid and any security devices (i.e. lock box keys & RFID KeyCards...) issued to the Corporation are returned.

The Corporation will submit separate Employee-Driver Applications. AutoShare will hold The Corporation responsible for debts due and owing in respect of the Employee-Drivers so long as the debts relate to use of vehicles that occurs prior to AutoShare being notified in writing that the Employee-Driver: is no longer an employee or no longer should have access to the vehicles, and all security devices have been returned.
